GENERAL INFORMATION

Tour price quoted is based on current exchange rates as of October 2009. Tour price (land only) is based on a minimum of ten (10) people and includes: 6 days and 5 nights in London; 4-Star hotel accommodation; ground transportation to scheduled activities which includes the services of a professional London Blue Badge guide; a Welcome Tea and 4 Full Afternoon Teas; 2-hour guided sightseeing tour of London; entrance fees to Woburn Abbey (with guided tour); Kensington Palace (with guided tour); Victoria & Albert Museum private tour; Tea History Walk; 5 Full English breakfasts; all guide and driver tips; VAT and service.

The pricing of this LAND ONLY tour is contingent upon a minimum number of ten (10) tour participants. While we will do everything to maintain the listed price, it is subject to change if there are changes in the economy that further weaken the US dollar's value in the United Kingdom.

Tour price does not include: airfare and travel insurance (which we consider necessary); meals not included in itinerary; passport/visa fees; overweight baggage fees; optional activities; personal expenses; and free-day activities.

AIRFARE

Domestic and International airfare reservations and the purchase of travel insurance must be made on your own. Best arrival airport is London Heathrow. You will make your own way from airport to our hotel which is near Russell Square in London.

The purchase of travel insurance is highly recommended.

CITIZENSHIP

A valid U.S. passport is required for this tour. PLEASE CHECK THE EXPIRATION DATE ON YOUR PASSPORT. If your passport is due to expire within 6 months after departure you will need to renew it.

HOW DO I PAY?

Subject to the terms hereinafter described, a deposit of \$499 per person, payable by check, is due by March 1, 2010. This deposit secures you a place on the tour. Another payment of \$800 is due by April 1, 2010; another payment of \$800 is due by May 1, 2010; and a final payment of \$800 is due by June 1, 2010. Totaling \$2,899.

CANCELLATION POLICY/FEEES

If the Tea in London tour is cancelled due to a lack of minimum number of participants, you will be duly notified and your deposit for this LAND ONLY tour package will be refunded in its entirety as well as any other monies you may have sent to us.
